

DOCUMENT 00 11 13 - ADVERTISEMENT FOR BIDS

1.1 PROJECT INFORMATION

- A. Notice to Bidders: Qualified bidders may submit bids for project as described in this Document. Submit bids according to the Instructions to Bidders.
- B. Project Identification: Munising Public Schools High School and Middle School Renovation.
  - 1. Project Location: Munising High School, 810 State Highway M-28, Munising, Michigan 49862.
- C. Owner: Munising Public Schools.
  - 1. Owner's Representative:

- E. Project Description: A single prime contract for the renovation of the existing high school/middle school building in Munising, MI. Project consists of reconstruction of the parking lot and driveways, site lighting upgrades, exterior improvements including roof and window replacement and masonry repairs, interior improvements including floor, ceiling, locker, bleacher replacement, signage and interior painting, science lab renovations, office renovation, lighting and technology upgrades, and mechanical upgrades including new controls.
- F. Project is anticipated to be substantially complete by:
  - 1. **Second floor classrooms and site by August 20, 2018.**
  - 2. **Remainder of building by August 27, 2018.**

1.2 BID SUBMITTAL AND OPENING

- A. Owner will receive sealed lump sum bids until the bid time and date at the location given below. **Owner will not consider or accept a bid received after the date and time specified for bid submission.** Owner will consider bids prepared in compliance with the Instructions to Bidders issued by Owner, and delivered as follows:
  - 1. **Bid Date: Tuesday, March 27, 2018.**
  - 2. **Bid Time: 10:00 a.m.**
  - 3. **Location: Munising Public Schools, Superintendent's Office, 810 State Highway M-28, Munising, MI 49862.**
- B. Bids will be thereafter publicly opened and read aloud.

1.3 REQUIRED AFFIDAVITS

- A. Affidavit of Bidder – Familial Relationship Disclosure

1. Each bid shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the Munising Public Schools Board of Education or the Superintendent of Munising Public Schools. **The Owner will not accept a bid that does not include this sworn and notarized disclosure statement.**
2. Complete and submit the "Affidavit of Bidder – Familial Relationship Disclosure" form included with Procurement and Contracting Requirements.

B. Affidavit of Compliance – Iran Economic Sanctions Act

1. Each bid shall be accompanied by a sworn and notarized statement that the bidder is not an "Iran linked business" within the meaning of the Iran Economic Sanctions Act, Michigan Public Act No. 517 of 2012. **The Owner will not accept a bid that does not include this sworn and notarized statement.**
2. Complete and submit the "Affidavit of Compliance – Iran Economic Sanctions Act" form included with Procurement and Contracting Requirements.

1.4 BID SECURITY

- A. Each bid shall be accompanied by a certified check made payable to Munising Public Schools or a satisfactory bid bond for 5 percent of the base bid.
- B. No bids may be withdrawn for a period of **90 days** after opening of bids. Owner reserves the right to reject any and all bids and to waive informalities and irregularities.

1.5 PREBID MEETING

- A. Prebid Meeting: A **mandatory** prebid meeting for all prime bidders will be held at the **Munising High School, 810 State Highway M-28, Munising, Michigan** on **Tuesday, March 13, 2018 at 2:30 p.m.**, local time.
