ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **2015 Village of Chesaning Paving Projects** will be received, by **the Village of Chesaning**, at the office of the **Village of Chesaning, 1100 W. Broad Street, Chesaning, Michigan 48616**, until **1:00 PM** local time on **September 30, 2015**, at which time the Bids received will be **publicly** opened and read. The Project consists of **milling and resurfacing of 0.85 miles and crushing and shaping 1.05 miles roadway. Additional work includes sidewalk ramp upgrades, curb and gutter installation, drainage improvements, and approximately 1.05 miles of water main replacement.**

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Checks for Bidding Documents shall be payable to "**OHM ADVISORS**". Upon request and receipt of the document deposit indicated above, the Issuing Office will transmit the Bidding Documents via delivery service. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Bid security shall be furnished in accordance with the Instructions to Bidders.
