Macon Road over Cammett and Luckhardt Drain Washtenaw County Water Resources Commissioner

Sealed Bids for the Macon Road over Cammett and Luckhardt Drain will be received until 2:00 pm local time, on **October 22, 2018**, by the Washtenaw County Water Resources Commissioner's Office located at 705 N. Zeeb Road, P.O. Box 8645, Ann Arbor, MI 48107. The approximate work involved is as follows:

Removal of an existing steel and concrete bridge approximately 32 feet wide and 15 feet long, placement of approximately 48 feet of 106"x68" concrete elliptical pipe and associated earthwork, cast-in-place concrete end treatments, general grading, approximately 30 feet of gravel road construction, restoration, riprap and associated work.

Bid Security in the form of a Bid Bond for a sum no less than five percent (5%) of the amount of the Bid will be required with each Bid.

Qualified contractors wishing to submit a bid must use the forms provided by the ENGINEER. Bids may be rejected unless made on the forms included with the bidding documents. Copies of documents obtained from any other source are not considered official copies.
